

Starting in March 2020 we met monthly as the pandemic ushered in a time of uncertainty. Silent Voice services moved seamlessly online but we knew that the finances would be impacted, and it was a time for all hands on deck. Our spring fundraising event was cancelled. Donors were being cautious of their giving as their financial situation too was uncertain. A profound thanks to all who gave to Silent Voice in 2020. Some financially, some of their time and expertise, and many demonstrating dedication over and above, including the Silent Voice staff team.

Deaf children and youth were also profoundly impacted by the pandemic and experienced increased isolation during this time. I know because my daughter is Deaf. She was sheltering in place with her hearing family members with no in-person Deaf peer, mentor, or community engagement. Silent Voice quickly increased their online presence with these children and youth to keep them engaged, informed, and interacting with their Deaf peers in order to reduce their feelings of stress and isolation.

Silent Voice directly impacts over 1200 individuals each year and indirectly impacts hundreds more. None of this would be possible without you, our stakeholders, members, volunteers, donors, funders, and the clients and families we serve. You inspire us to continue to strive to meet the need. Thank you.



Message from Jingchan Hu, Treasurer

It is my responsibility to present a summary of the Audited Financial Statements for Silent Voice Canada for the year ended December 31, 2020. A copy of the Audited Financial Statements is available to any member of Silent Voice and is posted on the Silent Voice website.

2020, we all know was an extraordinary year, starting in March with the COVID-19 pandemic and 'stay at home' orders. The pandemic had an impact on economies globally. Government rallied to offer flexibility and relief. Some core donors and funders reduced funding due to constraints while others increased funding to meet increased need. Revenues were \$1,390,338 for the year, down 4.8% over the previous year.

I want to thank Catholic Charities of the Archdiocese of Toronto (CCAT) for their continued funding and although there was a reduction in CCAT funding as a precaution due to the pandemic's impact on fundraising, Catholic Charities dipped into its reserves to ensure reductions were not greater. Catholic Charities continues to be one of our largest and most loyal of sponsors offering much more than core funding. Silent Voice participates in its shared services for medical/dental benefits and pension to our staff, shared HR, IT, and Financial Management services, evaluations and professional development, its network of agencies, and so much more.

Despite the financial impact on fundraising and fees for service, I'm pleased to report that we ended the year with a small surplus of \$7,160, which will be allocated to our reserve fund. All government and specially ear-marked funding was spent on the programs and services we offer. We were able to achieve this result through discretionary funding from our generous donors and decreased discretionary spending in 2020 by the amazing Silent Voice team with Executive Director Kelly MacKenzie at the helm.



One of our goals continues to be to increase our reserve fund to be more in line with the rapid growth Silent Voice has experienced over the last few years, so that we are able to sustain our organizational needs in the event of anticipated, or unanticipated shortfalls, especially as we are wading through uncertain times. There was less of an opportunity to do that in 2020 due to the pandemic, which hit charities quite dramatically.

The key financial resource for Silent Voice continues to be funding from our generous supporters. Silent Voice continues to request funding from government agencies, at all three levels, to provide funding up front where possible to minimize any risk of cash flow issues in our organization. We would like to thank the City of Toronto as well as the Ontario and Federal governments, for their partnership in enabling us to provide services to members of the Deaf community. In addition, the federal government through United Way of Canada, Community Foundations of Canada, and the Canadian Red Cross granted funds and supplies to help Silent Voice provide much needed materials and services to our clients and families who experienced undue hardship as a result of the pandemic.

The auditor for Silent Voice is Ian Edmonds, EPC Accounting. He has performed an independent review of the financial results for 2020. For 2020, consistent with prior years, he has provided a positive opinion on the financial results which is normal and expected for a charitable organization such as Silent Voice.

As members of the agency, funders, and stakeholders, you should feel confident that the agency is being properly managed as it delivers programs and services to the community, and that it has sufficient resources to keep on providing those programs and services.



Message from Kelly MacKenzie, Executive Director

Last time we met in person for a Silent Voice Annual General Meeting, the Toronto Raptors were taking the championship! But Silent Voice Canada is not only in Toronto, or the GTA, or its outskirts. Since 2015, we have successfully branched out across the province, and continue to grow. We have partners in other provinces. Silent Voice continues to be on a trajectory of growth although the pandemic curtailed some of that, starting in March 2020.

As Silent Voice Board Chair Shelagh Durno reported, our strategic plan is not one that collects dust but one that truly guides us and is measured and reported on.

To update you on the major strategic objectives and how they were met in 2020:

- **1. Family Communication Program** we continue to give more families American Sign Language (ASL) education in the Family Communication Program (FCP). At first families thought the "stay at home" order would be temporary so some halted their ASL instruction until we could provide services in person again. When it was clear that this was not a temporary state, FCP moved online and is conducted in areas across the province.
- **2. Ontario Infant Hearing Program (IHP) ASL Services** moved online as well. To our surprise, it was more effective and successful with some families than we anticipated. For others, we are as desperate as they are to return to in-person services.






3. **Deaf children and youth programming** - the isolation faced by Deaf children and youth has never been so pronounced. Our "Saturday Program" moved online and expanded to five, even six, days/week to meet the needs of families. The education system – online, in class, back online, hybrid – it was difficult for families to keep up. We provided outreach to ensure they were aware of the changing landscape. We provided homework support, in ASL, to help families, not proficient in ASL, assist with their child's homework. We went into overdrive providing peer and mentor engagement and support in ASL, online, whenever we could.

2020 hosted the first ever virtual Sign Language Summer Program (SLSP) day camp – SLSP@HOME! What a learning opportunity for all. But we knew we had to engage kids, in ASL, with peers and mentors in the first summer of the COVID-19 pandemic.

4. **Community Support Services** – also went into overdrive meeting the increased demand on service for information on the pandemic, public health restrictions, relief opportunities, navigating their children's education options, mitigating financial crises, moving online for everything, getting the equipment to do so, getting hampers of food and supplies. We had a real push over the holidays for hampers of food, toys, and supplies to support families. Thank you to Canadian Red Cross and donors like you who gave to the campaign!



- **5. Sustaining the organization** Silent Voice not only sustained itself, when sadly many charities did not do well and some closed their doors, we became a leader in the community, creating a web HUB for COVID information, tips, mental health supports, activities to do at home, and more. Our virtual doors remained open and our outreach to check on vulnerable clients and families was increased.
- **6. Funding** governments were generous, flexible, and caring, and continue to respond to the impact of the pandemic. Fundraising revenue was down as was predicted as donors attended to their circumstances; foundations received fewer funds and could give fewer funds, and corporations responded to competing and emerging priorities.

Those are some of the 2020 achievements aligned with our strategic plan, and during a global pandemic. But more important is the impact on those we serve:

- Enhanced & Accessible Communication at a time when information has never been more important, never been so fast changing, and families needing to communicate with one another as they shelter in place
- Barriers Navigated & Removed so many new systems put in place, different approaches to education, financial relief, and safety
- Engagement, Inclusiveness, and Outreach at every turn, even though everyone had to move online
- Skills and Knowledge Developed to learn how to function online, and cope with the new and changing normal



As she leaves the role of Chair, I wish to acknowledge her dedication, her passion, her critical thinking, her support of me and the staff, and her undying commitment to Silent Voice.

Thank you to all friends of Silent Voice, supporters, donors, members, volunteers, clients and families, partners and stakeholders. 2020 has been a year like no other and together we came through it braced for 2021. Thank you!
